

## PLANNING JUNGLE LIMITED - MEMBERSHIP TERMS AND CONDITIONS:

### Introduction:

The Planning Jungle Limited website contains a number of restricted areas that can only be accessed by members. The process for becoming a member is described in the "Become a Member" section of the website, and typically involves the payment of a specified fee for a specified period of membership. Each member is given a username and password that enables them to access the restricted areas of the website for the duration of their membership.

During the process for becoming a member, you will be asked to confirm that you have read and agree to these terms and conditions. These terms and conditions include that you are not allowed to share your username and password with anyone outside of your company or organisation, include details of what you are allowed and not allowed to do with the documents produced by Planning Jungle Limited, and include an important disclaimer.

### Individual or sole trader:

If you are purchasing your membership on behalf of yourself as an **individual** or a **sole trader**, then the following applies:

- You are entitled to use your username and password to access the restricted areas of the website for the duration of your membership. However, you are not allowed to share your username and password with anyone else.
- You are allowed to view, save, print, quote excerpts from (including in your applications and cases), and alter the documents produced by Planning Jungle Limited. However, you are not allowed to distribute or make available these documents (either in their original or altered form) to anyone else.

### Partnership, LLP, company, charitable organisation, or government organisation:

If you are purchasing your membership on behalf of a **partnership, LLP, company, charitable organisation, or government organisation**, then the following applies:

- You and any other people within your particular partnership, LLP, company, charitable organisation, or government organisation, are entitled to use your username and password to access the restricted areas of the website for the duration of your membership. However, you and these other people are not allowed to share your username and password with anyone else.
- You and any other people within your particular partnership, LLP, company, charitable organisation, or government organisation are allowed to view, save, print, quote excerpts from (including in your applications and cases), and alter the documents produced by Planning Jungle Limited. However, you and these other people are not allowed to distribute or make available these documents (either in their original or altered form) to anyone else.

### Any other types of organisations (including networks, forums, and other similar types of groups):

If you do not fall within any of the categories "individual", "sole trader", "partnership", "LLP", "company", "charitable organisation", or "government organisation", please contact Planning Jungle Limited for further information about the terms and conditions that would apply if you choose to become a member. Please note that it's **not** possible to purchase a membership on behalf of a network, forum, or other similar type of group.
